ROBINWOOD WEST COMMUNITY IMPROVEMENT DISTRICT

PROPOSITION

TWO-THIRDS MAJORITY
REQUIRED

Shall the Robinwood West Community Improvement District (the District), at the recommendation of the Board of Directors and the Elections, Bylaws and Rules Committee, amend its Bylaws in the following manner, so as to resolve the current conflict that exists between the provisions of the Bylaws and the Missouri CID Act:

Article V. Board of Directors.

Section 1.C. Term

Will read: The term of each Director shall be at least three (3) years and not more than four (4) years, which shall commence on the third (3rd) Monday of June, or upon certification by the County Board of Elections if election results are not certified by such date. One Director shall be elected to a term beginning on November 10, 2009 and ending on the third (3rd) Tuesday of June 2013. Two Directors (representing the Director seats currently held by Virginia Messersmith and Holly Day) shall be elected, each, to a four (4) year term, beginning on the third (3rd) Tuesday of June 2010. Two Directors (representing the Director seats currently held by John Motley and Jerry Polt) shall be elected, each to a four (4) year term, beginning on the third (3rd) Tuesday of June 2011. There will be no scheduled election in 2012. Thereafter, all successor Directors shall be elected to a three (3) year term of office. The elected terms shall expire at 12:01 a.m. on the third (3rd) Tuesday of June, or upon certification by the County Board of Elections if election results are not certified by such date.

Section 2. Elections.

Will read: Directors shall be elected in accordance with all applicable election laws. Directors shall be elected at large by RWCID membership in accordance with Section 67.1451 of the Act. Mail-in elections shall be held annually on the second (2nd) Tuesday of June. Elections shall be conducted in accordance with St. Louis County regulations (CSR 30-5.020) and other applicable County ordinances and rules, the CID ACT, Chapter 115, RSMo, and the Missouri Constitution.

Article VII. Meetings,

Section 3. Annual Meetings.

Will read: The annual meeting of the members of the RWCID shall be held immediately following the first regular Board meeting following the annual election, or as soon thereafter as practical, to install new Directors, elect District Officers, provide financial and other reports, and to conduct such other business as may properly come before the members.
